## **COOPERATION AGREEMENT**

**between**

**KONSTANTIN PRES LAVSKY UNIVERSITY OF SHUMEN**

**and**

**FSFEE HE "TAMBOV STATE TECHNICAL UNIVERSITY",  
RUSSIAN FEDERATION**

**Konstantin Preslavsky University of Shumen**, 115 Universitetska Str., 9700 Shumen, Bulgaria;  
represented by prof. Georgi Kolev, PhD, Dr. Habil, Rector

and **FSFEE HE «Tambov State Technical University»**, 106, Sovetskaya str., Tambov, Russia  
represented by Professor Mikhail Krasnyanskiy, Doctor of Technical Sciences, Rector

Hereinafter jointly referred to as Parties, and individually – Party, establish this Agreement to foster international cooperation in education and common research fields.

1. Both parties agree to encourage the following activities, in particular to promote International academic cooperation:

1.1 Exchanging students, scientists and academic staff to organize joint study and scientific programs including programs of additional professional training and internships within the frame of individual agreements;

1.2 Participation/organization of conferences, seminars and publication of scientific and methodical proceedings;

1.3 Reviewing scientific publication, thesis of dissertation, other research work;

1.4 Exchanging the information about seminars and scientific conferences organized by both parties;

1.5 Applying and participation in joint research projects;

1.6 Exchanging the information and documentation including methodical recommendations, scientific publications and research results.

2. This Agreement is not considered to be a contract with legal and financial relationships. Rather, it is designed to facilitate and develop genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the parties will arrange other agreements as supplements to the present one specifying financial and juridical responsibilities.

3. This Agreement becomes effective as of the date of signatures of both parties. The Agreement may be amended by the written consent of the parties.

4. This Agreement is valid for 5 years. It may be extended for additional periods upon the written consent of both parties.

5. This Agreement may be terminated with a minimum of 120 days written notice of any party.
